## **Fantastic's Mixed Trio Tournament Rules**

## **Mixed Trio Tournament**

(Format with one member of the opposite sex)

- This tournament will be certified by USBC (04650) and operate under USBC rules.
- 2. All bowlers must be current members of USBC. A bowler who is not certified this season can purchase a certification card the day of bowling for \$21.00. A bowler who enters the tournament without a current paid membership will cause a forfeit of his/her team scores and entry fee.
- 3. Format will be mixed with one member of the opposite sex. The total pin fall including handicap will determine the winners. The 3 games from each bowler's are the total score with handicap.
- 4. <u>THE ENTRY</u>: Total cost is \$120.00 (\$40.00) per bowler. \$36.00 is bowling fee and expense and \$84.00 prize fund per team entry. 100% of prize fee returned. The first place prize \$3,400.00 prize pay off will be determined by number of entries. 1 in 8 entries will cash based on 108 entries.
- 5. Late bowlers will receive zero for frames missed. (No Refunds!)
- 6. AVERAGES: All bowlers will list the highest average of 21 or more games from the 2020/2021 season (no summer averages). If a bowler has no average from 2020-2021, then 2019/2020 highest of 21 or more games will be used, not a composite average. The 10 pin rule is not in effect. Reporting correct averages is the responsibility of the team captain. Failure to report correct averages could result in the team being eliminated from the tournament. A bowler who has not established a yearbook average will be allowed to bowl but will enter the tournament with 190 average for women and 220 average for men. USBC rules 319D and 319E are in effect for all. It is the right of the Tournament Director to re-rate any bowler that is determined to be a detriment to the life of this tournament. BEWARE!!!!!!
- 7. <u>HANDICAP</u>: Teams will receive handicap of 80% from 660. An individual bowler who has an average above 220 will receive no handicap, but will not lose pins.
- 8. ELIGIBILITY: No PBA/PWBA current member or member from the past 5 years will be allowed to bowl.
- 9. There will be 15 minutes of practice. Any lane breakdown that is longer than 30 minutes may result in a new lane assignment. Any act of God, War, Storm or damage to the bowling center that could make it impossible to complete the tournament will result in entry refunds.
- 10. Reserved entries with payment will have the first right to openings. All other entries will be on a first come, first served basis. Walk-in entries are accepted only if space is available (Limited to 54 teams). Bowlers must check 15 minutes prior to the squad time, walk-ins close 30 minutes prior to the squad start time. NO TEAM WILL BOWL UNOPPOSED, IF ODD NUMBER LAST TEAM WILL RECEIVE A REFUND.
- 11. Any discrepancies or disputes must be reported to the Tournament Director immediately. All disputes will be settled by the Tournament Committee.
- 12. Same day payout of prize fund after both squads are completed bowling and averages have been verified.
- 13. All jackpots will be collected by the Tournament Committee.
